## CONSTITUTION AND BY - LAWS

## OF

## The Boeing Employees' Whitewater \& Touring Club

Preamble: We the members of the Boeing Employees' Whitewater \& Touring do organize for the mutual recreation and pleasure in the (1) practice of river floating and flatwater touring, (2) promotion and instruction in the use and handling of whitewater and touring craft, (3) fostering good sportsmanship and safety practices, (4) preservation and protection of the natural resources, (5) recognition of and proper respect for the rights of landowners.

## CONSTITUTION

## ARTICLE I NAME

Section 1 We shall be known as the Boeing Employees Whitewater \& Touring Club, abbreviated as BEWET.

## ARTICLE II MEMBERSHIP

Section 1 Membership shall be open to the following without regard to race, color, religion, national origin, gender, sexual orientation, gender identity, age, physical or mental disability, or veteran status.
a. Boeing employees and retirees.
b. Spouse and eligible dependent children (as defined by Boeing benefit guidelines) and domestic partners as defined by The Boeing Company of Boeing employees and Boeing retirees.
c. Government, customer, vendor and contract personnel stationed at or exclusively serving The Boeing Company, their spouse and dependents.
d. Certain limitations may be imposed by the company on participation for other than company employees based on available staff, facilities and budgets.
e. Non-Boeing employees whom are eligible per the Enterprise Recreation Associate Membership Policy.
f. Other non-Boeing individuals proposed for participation and approved by Enterprise Recreation.

Section 2 Annual dues shall be established by the Executive Board on a calendar year to calendar year basis.

## ARTICLE III OFFICERS

Section 1 The officers of BEWET shall consist of a President, Vice President, Secretary and Treasurer. The Treasurer of the club executive board must be an active Boeing employee. Eligible candidates for President, Vice President, and Secretary of the executive board may be an active Boeing employee or a retiree of The Boeing Company.

## ARTICLE IV DUTIES OF OFFICERS

Section 1 President shall:
a. Preside at all business meetings.
b. Be chairperson of the Executive Board.
c. Call extra business meetings, appoint committees not otherwise provided for and fill protem vacancies as specified.
d. Perform such other duties as the office may require.
e. Perform the duties of the Vice President in their absence.
f. Review the monthly bank statement with the treasurer.

Section 2 Vice President shall:
a. Oversee and coordinate the efforts of all major committees.
b. Perform the duties of the President in their absence.

Section 3 Secretary shall:
a. Keep minutes of all Executive Board and other business meetings.
b. Maintain an up-to-date roster of members.
c. Notify members of all club meetings as specified.
d. Maintain all required documents of the club.

Section 4 Treasurer shall:
a. Keep an accurate account of all financial transactions of the organization.
b. Be responsible for all funds of the organization and receive and disburse all money subject to the will of the Executive Board.
c. Disbursements shall be made by check or electronic payment such as PayPal or BECU POPMoney. A checking account will be set up and no check will be honored by the bank for payment unless signed by the Treasurer, or one other elected officer of the organization.

d. Maintain accounts and render monthly financial statements of the organization.
e. Review the monthly bank statement with the President.
f. Review the financial records with an officer or club member upon request.

Section 5 The Boeing Company provides Recreation Advisors who will provide administrative support and oversight as required to the Executive Board.

## ARTICLE V ELECTION OF OFFICERS

Section 1 The offices of President, Vice President, Secretary, and Treasurer shall be filled by election at the first regular meeting as defined in the club's operational procedures.

Section 2 Nominations for officers of the organization shall be made by a three-person Nominating Committee appointed by the President at the September meeting.

They shall present a list of nominations to the organization to be voted upon at the first regular meeting in October.

Section 3 No person is eligible to hold office that is not a dues paying member of the organization.

Section 4 No member is eligible to hold more than one elective office at a time or be retained in office more than two successive term limits. The length of a term is defined as: one fiscal year.

Section 5 Only one member of a family, the active Boeing employee or Boeing retiree at a time is eligible to hold the office of President, Vice-President(s), Secretary(ies), or Treasurer. This also applies to appointed voting members of the executive board.

Section 6 All elections shall be by secret ballot.
Section 7 Office vacancies of the President, Vice-President, Secretary and Treasurer must be filled within 60 days of vacancy either by appointment by the board or special election.

Section 8 No officer or trustee shall receive any salary or wages by reason of office.

## ARTICLE VI COMMITTEES AND BOARDS

Section 1 There shall be an Executive Board, and 2 major committees.
Section 2 Executive Board
a. The President, Vice President, Secretary, Treasurer, and all major committee heads shall constitute this Board.

b. The Executive Board shall decide on all expenditures, promotion of activities, appointments of committees and the general government of the organization.

## Section 3 Committees

The BEWET major committees shall be the Training Standards Committee and the Sea Kayaking Committee.
a. The Training Standards Committee shall arrange for the development of standards and cirruculum around Guide Training, both for the Sea Kayaing and Whitewater portions of BEWET. This committee will also facilitate this training and ensure its compliance with and exccedance of Washington State and other applicable laws.

It shall consist of Chairperson and a minimum of 2 senior members appointed by the Chairperson.
b. The Sea Kayaking Committee shall plan and organize trips around the Flatwater portion of the BEWET club. They will also work with the Training Standards Committee to ensure that Sea Kayaking leadership is compliant and exceeds all expectations set by Washington State and other applicable laws.

It shall consist of a Chairperson and 2 senior members appointed by the Chairperson.
c. Sub-committees to the major committees may be formed at any time to carry out the various phases of the club activities.

## ARTICLE VII MEETINGS

Section 1 Regular meetings shall be held according to a schedule decided upon and provided to members at the beginning of the year. Meeting changes shall be provided with one week minimum prior notice.

Section 2 Special meetings may be called at any time as determined by the President.
Section 3 All meetings will be conducted in compliance with Robert's Rules of Order.

## ARTICLE VIII

Section 1 This constitution may be amended by the submission in writing of a proposed amendment at any regular or special meeting of the organization. The proposal shall be received and acted upon at the next succeeding regular meeting of the organization at which there shall be a quorum present (present is defined as in person).

Section 2 Amendments may be acted upon at the announced meeting or by mail ballot. A two-thirds majority of the members present at the meeting or responding by mail ballot shall be required to adopt an amendment.

Section $3 \quad$ Written notice of the meeting shall be given three weeks prior to the meeting at which the amendment is voted upon.

Section $4 \quad$ All proposed amendments to this constitution and by-laws shall be submitted to Boeing Recreation for clearance before a vote by the membership.

## BY-LAWS

## ARTICLE I <br> QUORUM

Section 1 A quorum for Constitution changes shall consist of $10 \%$ of the paid membership, including 3 of the 4 members of the Executive Board.

Section 2 A quorum for day-to-day business shall consist of members present including at least 3 of the 4 members of the Executive Board.

## ARTICLE II <br> GENERAL PROVISIONS

Section 1 Property or equipment purchased by BEWET with BEWET funds shall be considered club property and not the property of any individual member or group of members.

Section 2 The fiscal year for BEWET shall be from January $1^{\text {st }}$ to December $31^{\text {st }}$, inclusive. All budgeting and financial accounting shall be rendered on this basis.
